1. Please complete both sides of this reservation form, review our Terms & Conditions, sign the form and mail it to us with your payment.
2. Final payment and liability release forms must be received by Jerkwater at least 10 days before your trip. Trips including 10 or more people are eligible for a 10 percent discount if the trip is fully paid at least 10 days before the trip. Discount applies to canoe trip only – it does not apply to destination fees or other items. (Discount will not apply to participants added less than 10 days before trip.)

3. Please arrive at your launch location one-half hour before your launch time; for Hoover Dam launches, you need to arrive an hour before your launch to allow time for the security check.
4. Camp fees are not included; we do not own or operate any campgrounds. You can reach Park Moabi at 760/326-3831.
5. Shuttles and transfers between Bullhead City and Lake Havasu City begin and end at Park Moabi. If you are planning a multi-day trip between Bullhead City and Lake Havasu City, you are welcome to leave your vehicle in our gated yard at Park Moabi. You will be required to pay the park only for the nights you camp there (minimum one night camp fee).
6. Black Canyon launch permit and Lake Mead National Recreation Area fees are not included in the price of your trip. Call us to book permits and have a credit card number, billing address, security code from back of card and card expiration date ready, as payment is required at the time for issuance of the permit. Permit fees are not refundable.
7. Shuttles and transfers for Black Canyon begin and end at the Hacienda Hotel & Casino parking lot.
8. Minimums: If your group does not meet the minimum group size for the trip you want, call us to see if we have a trip booked for the same area. If so, you are welcome to join in.
